- IBB Update
  - Ratified the contract.
  - Payroll started working to adapt the contract assuming approval.
  - Adjustments will take place first with Full-Timers and then with Part-Timers.
    Adjustments in compensation will be retroactive.
  - Make sure to watch your paycheck.
- .5 Reassigned Time
  - Part of the contract was .5 reassigned time for KCCD CCA. Plan to discuss at the next KCCD CCA Executive Council Meeting.

# DISCUSSION

- Athletic Coach Hiring at BC: Ann Tatum
  - This is a return topic.
  - Dovetails with topics concerning Title IX from the Board Meetings.
  - Lost 5 full-time faculty coaches.
    - 4 of the positions have been replaced by professional experts.
    - However, the full-time faculty positions remain but are not coaching. So it's not a loss of faculty positions.
- Payroll Issues: Sharlene Paxton
  - Dispersements to 403b are occurring late.
  - Concern:
    - There is a concern about why the disbursements are late and whether interest is being accrued as a result by the district office.
    - [ACTION] KCCD CCA President Matt Crow to research and discuss with Vice Chancellor of Human Resources.
- Library Mode-A/Mode-B Evaluation Forms: Matt Andrasian-Jones
  - BC Librarians want to know the process to get the content on evaluation forms changed.
  - They are primarily interested in forms M, L, and N.
    - Form M they would like fillable.
    - Form L there is a question if #3 can be changed to be more instructional focused.

- Form N they would like to see changes to questions 1, 3, 5, 6, 7, 8, and 9.
- When these forms are being completed at Cerro Coso, they may be observed during a one-on-one, and not everything is always applicable. For those that aren't applicable, their practice is to add "Don't Know" and margin comments.
  - The hope is that all faculty Librarians could convene and discuss this.
  - Maybe an additional evaluation form should be created for the purpose of use during workshops?
  - Evaluation has to be bargained and involve the Academic Senate.
  - Ad Hoc- Senate Librarian Evaluation Form Committee.
    - Might be able to be folded into the DEIA evaluation.
  - [Action] Matt Crow to send communication to all district Senate Presidents.
