- IBB Update
  - VC Human Resources-Open Negotiations
    - Part-Time Healthcare
    - Negotiators are willing to open.
    - Both teams need to sunshine any items being brought forward.
    - The district has indicated they want a January CPI Date, but CCA wants to push for a March date.

### **DISCUSSION**

- .5 Reassigned Time
  - It was suggested that it should be considered that the treasurer and secretary should get some reassigned time.
  - It was also suggested that if the CCA President gave up reassigned time, that position should receive some of it back.
  - There was discussion around adding a stipend/reassigned time to membership and elections.
  - [ACTION] Matt Crow to reach out to Treasurer Sherie Burgess, and present a full proposal at the 11/20/23 meeting.
- Library Mode-A/Mode-B Evaluation Forms Follow-Up: Matt Crow
  - It is going to involve the Academic Senate. He is still waiting to hear from two Senate presidents.
- Add Conference Report (Buzz Piersol, E. Paden Burgess, and Justin Bell)
  - Buzz Piersol:
    - Noticed larger part-time advocacy than eleven years previous.
    - EERA- Used outdated examples of KCCD as a model for unfair labor practices.
    - Tools to use if the district isn't negotiating.
    - Grants: Discussed different grants. They want the union to chip in, but no specific amount was stated.
    - Innovative Proposal
    - Update to the bylaws. Every instance of adjunct was changed to Part-Time.
  - E. Paden Burgess

- 1st conference
- Attended DEIA
- DEIA is from a change in Title IV and Ed Code.
- The timeline suggests we all need to implement by December 20th.
  - However, it is stated that there is a need to agree on competencies and criteria.
- Questions arose around DEIA Training every 3 years.
- Referred to an item called the template of DEI Competencies
- o Justin Bell
  - Plan has to be offered to full-timers.
  - 50% reimbursement is automatic, after that District can apply for the other 50% to be reimbursed. They need to apply by June 1st. Offer it to equal or greater than 40%. Limit Individual Premiums.
