<u>Title 5 Distance Ed topic: Ann</u>

- Erica Menchaca presented and stated she is sharing the information with all relevant parties.

- Currently the status is awaiting District Level Decisions.
- Erica is also conducted an informal touch base with CC and PC Leads.

Advisors vs Counselors: Ann

- Overview- Victor Diaz shared that at a divisional meeting their Dean shared a couple of Policies, specificall referencing administrative language. He wanted to point out, that he looked as far back as 2017 to language in the administrative procedure. A concern was voiced that they are mandated to provide a level of student services... The administrative language states "counselor/advisor." He clarified the concern regards the position and not any specific individual. The concern is that the duties can start bleeding into what is faculty/counseling perview.
- Questions were asked regarding what educational advisors are doing that counseling was typically doing?

- There are still discussions that need to occur in order to truly determine what issue(s) there are and how it needs to be handled.
- There needs to be a clearer delineation between Educational Advisors and Counselors.
- A question was asked if CSEA has stated their standing in this issue?
 - Ann Tatum will reach out to CSEA.
 - It was stated that CSEA is typically particular about working "out of description."
 Their standpoint is typically if there is a change in description there should also be a change in compensation.
- It was mentioned that it would be interesting to look at Advisor roles district-wide.
 - Victor and Matt to establish a meeting with all counseling chairs district-wide.
- Counseling has not had faculty positions hired.
